

SEMI-ANNUAL ASSESSMENT OF THE CONTRACT OF LIQUIDITY COMPAGNIE DES ALPES CONTRACTED WITH ODDO BHF (PARIS)

January 5, 2020 - Under the terms of the liquidity agreement entrusted by COMPAGNIE DES ALPES to ODDO BHF, as of 31/12/2020, the following resources were listed in the dedicated liquidity account:

- 29,299 shares
- 221,852.91 euros

As a reminder, on the date the agreement was signed, the following resources were listed in the dedicated liquidity account:

- 21,909 shares
- 379,150.38 euros

During the period running from 30/06/2020 through 31/12/2020, the following transactions were completed:

- 744 buy transactions
- 854 sell transactions

Over this same period, the volumes bought and sold represented:

- 56,338 shares and 957,533.8 euros bought
- 54,530 shares and 939,746.8 euros sold
