

SEMI-ANNUAL ASSESSMENT OF THE CONTRACT OF LIQUIDITY COMPAGNIE DES ALPES CONTRACTED WITH ODDO BHF (PARIS)

January 4, 2022 - Under the terms of the liquidity agreement entrusted by COMPAGNIE DES ALPES to ODDO BHF, as of 31/12/2021, the following resources were listed in the dedicated liquidity account:

- 27,729 shares
- 421,677.21 euros

As a reminder, on the date the agreement was signed, the following resources were listed in the dedicated liquidity account:

- 21,909 shares
- 379,150.38 euros

During the period running from 30/06/2021 through 31/12/2021, the following transactions were completed:

- 814 buy transactions
- 953 sell transactions

Over this same period, the volumes bought and sold represented:

- 98,441 shares and 1 350,581.62 euros bought
- 94,740 shares and 1 301,631.04 euros sold
